Qualitative analysis of Criterion 1

Govt. Lal Shyam Shah College, Manpur was established in the year 1989, in a remote Left-Wing Extremist, F Manpur to fulfil the higher education needs of tribal population. Since 2016 college is affiliated to Hemchand Y Vishwavidyalaya, Durg. College has its vision & mission to provide quality education for Tribal people and other sections and to develop the sprit of enquiry and scientific thinking by providing instructional and research facilitie arts, tradition, culture, language, medicinal system, customs, Forest based economic activities, etc. In order to fulfil goals and objectives, college is offering ten programmes; at undergraduate level B. A. (in Hindi, English, Econo Geography, political Science and Sociology) and B. Sc (in Maths and Biology); at Post graduate level Arts (Hindi, Geography, political Science & Sociology) and Commerce subjects are offered; following the curriculum of affi University. College is effectively implementing the curriculum adhering to the academic calendar of the affiliating u A., B. Sc., M. A., B. Com & M. Com programmes are being offered in Hindi medium.

Teachers make month wise teaching plan for academic year, daily diaries of teachers, attendance registers at academic records are being maintained properly. Students feedback is taken on teaching-learning. NSS unit of the organizes special camp in nearby left-wing extremists affected villages, where programmes are organized on literac issues, cleanliness drive and general health awareness. College follows the syllabus of the Hemchand Yadav Vishwa Durg. Teachers use ICT enabled tools for effective teaching learning. During Covid-19 teachers used various online for conducting online classes such as CISCO WEBEX, GOOGLE MEET and Zoom. Centralized online classes w conducted with the help of Higher Education Chhattisgarh (HECG) portal. The annual examinations are conducted Internal and half yearly exams (10% weightage) are conducted and marks are added to annual results. Admission Centralised at University level and Reservation policy of State government is followed. College has its own Webgraduate students are encouraged to incorporate research culture and data analysis in their class assignments and pro-Teachers convey the programme outcomes, programme specific outcomes and course outcomes to the students. Col centre of distance education of Pandit Sunderlal Sharma (Open University) Chattisgarh, Bilaspur. All teachers ider learners in their respective subjects and help them to cop up with the curriculum. University integrates cross cuttin relevant to Gender, environment, sustainability, Human values and professional ethics in the Syllabus. Under the bar Ribbon Club college organizes awareness programmes related to AIDS and sexually transmitted diseases. Systema Education and electoral participation programme are also organized. Students of NSS participate in plantations, clean abuse, etc. Students are motivated to pursue higher education, exposure of competitive exams and job opportunities union and Anti-ragging committee are also there to provide safe and secure environment. ### Qualitative analysis of Criterion 2

College admission date is announced by the University and Admission policy is Centralised at University level. Online applications are invited for admission in various colleges. Reservation policy of State government is followed for SC, ST and OBC students. Students number in various courses was: 449 in 2016-2017; 414 in 2017-2018; 528 in 2018-2019; 586 in 2019-2020, 799 in 2020-2021, 1079 in 2021-22 and 1087 in 2022-23. College is a co-educational college.

Based on the performance of the students in examinations and performance in internal exams, slow and advance learner students are identified. Teachers assess the nature of their problems and then motivates them to solve their problems. Extra classes are organized to clarify their doubts and re-explaining of difficult topics for improving their performance. Experiential learning and ICT based teaching learning process is encouraged. Teachers adopt two-way communication methodology in class and to make understand through diagrams and examples. Students are encouraged to take help of computer, internet and books from college library. For assignments, projects and online classes, WhatsApp groups are created for providing the knowledge through ICT tools. Projects are given to initiate research orientation among students. Projects, based on Environmental awareness are compulsory at the UG level. Class tests, tutorials and unit tests are conducted time to time for keeping the competitive spirit among students.

All teaching materials have been uploaded on the website (WWW.cgschool.in) in video, audio-visual and pdf format. The video lectures having more than 50 MB have been uploaded first in youtube and linked with site. Internal examinations are conducted in same way as annual examination through question papers. Grievances of students regarding internal exams are resolved timely. Grievances related to semester and

annual exams are also addressed and resolved at college level and university level. All programme outcomes, programme specific outcomes and course outcomes are available in syllabus and communicated to teachers and students. Students are also encouraged to take part in competitions, seminars and conferences. College also focuses on grooming the overall personality of students and encourages bright students to pursue higher studies in reputed universities.

Teachers are efficient and well qualified. Two permanent Assistant Professors are having Ph.D. degree and three are Post graduate. Out of nine temporary teachers: one guest lecturer is having M. Phil degree and eight are Post Graduate only. College is also encouraging the teachers for participation in orientation, refresher and faculty upgradation programs.

College follows the academic calendar of the affiliated university and examinations are held timely as per the schedule.

Qualitative analysis of Criterion 3

Resource mobilization for research is nil. Two permanent Assistant Professors are having Ph. D. degree and one is having M. Phil degree and all these are having good research experience. They have published several quality research papers with good citations. One book chapter has also been published by a senior faculty member. One senior faculty member is also recognised as research guide for supervision of Ph.D. Research Scholars. A separate research committee needs to be established for motivation of teachers towards research and for seeking funds for research. Initiatives in this direction should be taken by the College Authorities to strengthen the research culture.

College is located in Naxal affected remote tribal area; hence college organizes and participates in various extension activities in order to sensitizing the students about various social issues and contribute to society by doing community participation.

College organized some events like quiz, personality development programmes, speech and debate competitions, etc. Students are encouraged to participate in group discussions and public speaking activities in order to boost their confidence and communication skill. Students of PG classes are encouraged to undertake Project work related to existing social problems or subject specific topics. Students also visited Zoological Park, nearby Forest areas in order to make them familiar with the surrounding flora and fauna and traditional medicinal plants.

NSS unit of college organized various activities in seven days special camp and the activity on alternative

Saturday. In daily activity programmes students learn to maintain cleanliness and maintaining garden, constructing pavements, levelling playground, plantation, etc. In camp project work and socio-economic survey and cultural programmes are conducted.

With the help of Red Ribbon Club and Youth Red Cross society, college also conducted the invited talks on female health problems issues, malnutrition's, blood group testing, haemoglobin testing etc. World AIDS day is also observed to develop awareness. Voters Education, Electoral participation, Swachh Bharat Abhiyan, Yoga day, Hindi divas, Unity Day, Fit India pledge, World Aids Day, Human Rights Day are other awareness programmes, conducted by the College.

### Qualitative analysis of Criterion 4

The College has adequate teaching learning physical infrastructure and facilities. Total campus area of college is spread over 16.07 acres where build-up area is 1600 square meters. Boundary wall has different types of paintings showing tribal arts, social issues related paintings and some environmental paintings which give good message to save nature.

College has 12 well-structured classrooms, sufficient seating arrangements and electricity. Six classrooms are equipped with projectors. College has two small sized but sufficiently equipped laboratories for all experimental learning activities of Zoology, Botany, physics and Chemistry. One separate laboratory is there for geography.

College has a study centre of Pt. Sundarlal Sharma open University. College has separate rooms for Principal, Staff and Examinations. There is also one office room attached with one store room. College has its own playground and one badminton court.

College has a Gymnasium with adequate modern exercise equipments and gadgets like tread mill, bicycles and squat rack, Barbell, Pulley, Dumbell and pull up etc.

College has also newly constructed mini garden.

College has Six computers with internet facilities and one lap top. CCTV Cameras at different points cover the whole campus. College has also one LED TV, two photocopy machines, two printers, one portable Wireless Amplifier Set and one Ahuja portable Lectern System.

College has two bore wells, one water storing overhead water tank, one R.O. Kent system and two water coolers. Separate Washrooms for boys and girls and enough parking space for bicycle, two wheelers and four wheelers are there. Separated Boys and Girls hostels are being constructed.

College has large space for playground. Outdoor games like 100 meters, 200 meters, 400 meters races, high jump, long jump, javelin throw, discus throw, slow cycle race, musical chair are played. Open ground is available for playing Cricket, Vollyball and football. College has also been organizing internal tournaments for encouraging sports talent among students. Players are also provided free sports kit, track suit, T-shirts and pants.

College Gymnasium outer wall is painted with different Asans of Yoga. Courtyard open space for yoga is available. Practice of Pranayam and meditation is also taught. Anulom-vilom, kapal bhati, Bhambri, vajrasan, etc. are practiced.

The College has good library having approximately 18,000 books including text books, reference books and competitive exams books. Books are made available through UGC Book Bank, BPL Book Bank, and ST/SC Book Bank. Books are issued to students, faculty members and staff.

College has ICT facility which is frequently updated for teaching learning activities. The College has well established system and mechanism for maintaining and utilizing the physical, academic and support facilities like laboratories, library, sports room, computer systems and class rooms etc.

College has wi-fi facility. *Janbhagidari samiti* has been formed for making the college more accountable and generate local funds for developments. In every academic session, a small amount of fee is collected from the students under *Janbhagidari fees*, from this fund college maintenance and development works are carried out.

### Qualitative analysis of Criterion 5

Mechanism of identification of slow and fast learners and remedial classes in college is strong and effective. Extra classes are organized to assist slow learners. Previous years question papers are also provided to make understand the examination patter. Over all slow learners are encouraged to study well and improve their performance. Government provided scholarship to both UG and P.G. Students. number of students benefited by scholarship scheme is about 679.83. Students received scholarship under the government schemes for reserved categories were 260 in 2016-17, 273 in 2017-18, 404 in 2018-19, 437 in 2019-20 and 593 in 2020-21.

After the completion of their graduation some students pursue higher education. Faculty provides the full details and guide lines for selecting suitable such higher studies Institutions.

Student placement in various government jobs is in place and many students got jobs in teaching, police and private sectors. University results have also consistently been progressive.

College has anti-ragging committee. Students also represents on various extracurricular bodies including Boys/ girls NSS Committee, Red Ribbon club, red cross society; prevention of sexual harassment committee and cultural activity committee. College has not Registered Alumni Association, but college invites Alumni to contribute for the development of the college. Alumni helps in terms of their innovative ideas, inspires and motivate the students through class-room visits, interactions and lectures. Alumni also helps us in maintaining our computers and CCTV. Student alumni association. NSS activities like social awareness rallies, environment awareness programs, blood donation camps, cleanness drives, etc. are organized by the college, every year in seven day special camps, organized by the college in selected nearby village areas.

The College has separate Counselling and Career Guidance cell. The College also provides Remedial coaching for the preparation of NET/SET exams. 58 students are registered for NET/SET remedial coaching and recently two students qualified NET/SET examination.

### Qualitative analysis of Criterion 6

Vision and mission of the college is to provide quality higher education to the students from poor tribal population of Naxalite area and other weaker sections of Manpur and nearby areas of Chhattisgarh. in order to make them aware socially, culturally and intellectually and for their economic upliftment, self-reliance and also to enhance their human values.

Effective leadership is visible in various activities and practices in the college for decentralization, harmonious atmosphere and collective team management, which is also in tuning of the vision and mission of the college. Robust and effective Decentralized plan of power is being followed.

The functioning of various departments and sections is effective and efficient following the rules and regulations. Principal being an executive head of the institution for all academic and administrative process

has well defined set of powers and responsibilities. Principal has decentralized college work to different committees. Delegation of work to all HoDs, faculties and staff. Committees are responsible for planning and implementation of the activities. These committees are: Admission committee, Examination & scholarship for verifying examination forms, Purchase committee, IQAC cell, Nodal in charge of Vidhan Sabha question, Aisha Nodal officer, NSS programme officer, student in-charge, Annual function committee, etc. Office work is also distributed among non-teaching staff. In order to expose the students to the outside World, they are taken for the educational tour. A number of extracurricular activities like quiz, debates, group discussions are also organized to improve the student skill and abilities.

Teachers are encouraged for improving their educational qualifications, especially for perusing their Ph.D. degree. Teachers are also encouraged to attend conferences, seminars and to present their research papers. The administration motivates faculty to attend the refresher and orientation courses. The College has effective welfare measures for teaching and non-teaching staff. For Teachers, College has Group insurance, Provident fund, medical leave& medical reimbursement and also there is the provident fund for non-Teaching staff. Grant advance and uniform allowance only for class four employees.

Performance of faculties is fixed by appraisal system, as laid down by the state government, following the Annual confidential Reports. For teachers Performance Based Appraisal System (PBAS) has been introduced. Areas of improvements of teachers are collected through student feedback. API is used for carrier advancement of faculty members. Promotion rules of non-teaching staff are in accordance with the state government rules.

The external auditing is done by the State government agencies. Teacher in charge does the internal audit every year. Janbhagidari account is audited by the charted accounted. College has Internal Quality Assurance Cell (IQAC) without separate room and infrastructure. It helps in enhancing the infrastructure and motivating students. It helped in establishing the help desk for college students. The working of IQAC is transparent and clear.

### Qualitative analysis of Criterion 7

The college is regularly working on its vision and mission as is reflecting in its various activities. The College is providing the higher education to the poor tribal from poor tribal population of Naxalite area and other weaker sections of Manpur and nearby areas of Chhattisgarh, predominating inhibited by ST students almost 80%. There was no facility of higher education in this area before the establishment of this College in the year, 1989. The College is providing higher education to all sections of society, particularly to the poor and tribals, economically and socially backward classes of society in order to develop them academically. College provides scholarship to the needy students through post metric scholarship and BPL scholarship and providing stationary items also. College has sufficient infrastructural facilities for the students coming from the remote villages of Chhattisgarh. According to the local needs, the college offers UG courses in Arts, Commerce & Science and PG courses in Arts and commerce.

In order to develop the personality of the students and also to make them ready to take part in national and global level competitions, in co-curricular and extra-curricular activities, college efforts continuously. In the academic interest of students, Competitive Examination Guidance is provided by the college. College strives to prepare the students good human being who will care their future generation, as most of them first line learner in their families. Being ensconced in the nature surroundings of Forest, hills and ponds college encourages students to explore the surroundings and learn the ways to gainfully benefit from it while maintaining its pristineness and the ecosystem. College develops among students intrinsic values of education more because it enables the students to get employment in both organized and unorganized sector. College encourages students to rise from a simple worker to entrepreneur level.

Use of ICT based modern technology and allied teaching aids are adopted by the faculty to make the teaching learning process more effective and easier. Hindi divas is celebrated to promote and realize the importance of National language Hindi. To promote local dialect Chhattisgarhi, Chhattisgarhi Bhakha Diwas is also celebrated to encourage to speak Chhattisgarhi. Tolerance for the other religions is taught in class rooms Chhattisgarh is proud of peaceful and harmonious society. College makes efforts to educate and impart the constitutional values, rights, duties and obligations towards the society and Nation. Preamble, fundamental rights and fundamental duties mentioned in the Indian constitution are displayed in college campus. National festivals Independence Day and Republic Day are celebrated every year to make everyone feels National spirit and to realize sacrifice made by our freedom fighters. Constitution Day is observed on 26th November. Every year on 25th January Voters Day is organized, at this occasion, students were made aware and motivated about using their voting rights. Under SVEEP, systematic voter education & electoral participation awareness is also done by students. Faculty members, administrative staff and students take Voter's pledge. Human Rights Day is observed every year to declare that every individual person has inalienable human rights. Students are encouraged to do their work by themselves like opening bank accounts, making caste certificate, domicile certificate and income certificate from choice centre or from Tehasil Office. New courses are introduced in post graduate level as M.A. Sociology and M.Com. in U.G. level B.Sc. (Biology) course has been started. As a best practise, the college makes no distinction of gender, region, religion, caste, creed or class as the institution believes in the principles of liberty, equality and fraternity which foster human democratic values.

After completing graduation in this college, several students are placed in various jobs in Police Department, government and private sectors. Some students from this college after completing their graduation, opted for higher education in master's degree like M. A., B. ed., M.Sc. and M. com.

### **Overall Analysis**

### Strength:

- Since its inception in the year 1989, the college has strived hard to impart higher education to Naxalite affected poor tribal area and other weaker sections of the rural area of Manpur.
- The total campus area of the college is 16.07 acres including the build-up area of 1600 sq

mtrs. The campus comprises 15 rooms as main building including class rooms, library,

administrative block. The College has twelve classrooms of which six class rooms are

equipped with ICT; with 6 computers along with one smart board.

- Committed and dedicated faculties with two Ph.D. and one M. Phil degree.
- All S.C., S. T and O.B.C. Students are aided with Govt. Scholarships.
- Career and counselling cell for creating awareness among students for different Employment opportunities and career options.

### Weaknesses:

- The college has limited focus on research and lack of research fundings.
- Non availability of linkage with industries for the placement of passing out students.
- Low funding, for college maintenance and almost zero funding for Research.
- Poor library arrangement due to non-availability of Library staff, including librarian/ Library assistant.
- In-adequate infrastructure.
- In-adequate laboratory facilities.
- The College has in-adequate infrastructure for indoor and outdoor sports facilities.
- There is deficiency of full-time permanent staff in the college.

### **Opportunities:**

- Single Postgraduate Govt. college in the area.
- Some value-added courses and certificate courses can also be introduced.
- Research and innovations activities are to be strengthened with research facilities.
- Linkage/ MOU with other national and international organizations will open the new doors of awareness and opportunities.
- Scope is available for comprehensives use of Campus infrastructure including Gym room, play ground etc.

### **Challenges:**

- Due to poor economic backgrounds, students can not devote full time to study.
- Poor road conditions and poor transportation is also a challenge to reach the students to college.
- A large number od students are first generation learners causes the slow learners.
- Being located in rural and distant area, linkage with Industries and research organizations is a challenge for giving the exposure to students.

Encroachment of land area of college by local persons is also a challage to the college authorities.
